I understand that by participating in this tournament that I may cause or sustain injury including but not limited to: loss of limbs, paralysis, coma, loss of mental functions, loss of sight, loss of speech/smell, dehydration, exposure, hypothermia, frostbite, sun stroke and all other injuries that may be caused in a boating accident and/or exposure to the elements. I further release Exelon for all Losses relating to adverse weather conditions in this tournament. It is my responsibility to seek safety should adverse and/or unforeseen weather conditions occur prior to, during or after the tournament.
- B. **COVENANT NOT TO SUE AND WAIVER OF SUBROGATION:** In signing this agreement, I further covenant and agree not to sue Exelon for damages on account of any injury, death or damage I suffer or cause whether known now or which may develop in the future, and I expressly waive any right to sue that I may have. In the event Exelon is sued because of my actions, I expressly agree to indemnify and hold harmless Exelon from and against any losses. I understand that in waiving my right to sue Exelon, I am also waiving the rights to recovery from Exelon of my insurance carrier for any claims they may pay on my behalf.
- C. **VERIFICATION OF LIABILITY INSURANCE:** I verify that I maintain a minimum of \$100,000 liability insurance on the boat I will use in this tournament.
- D. **POLYGRAPH/VOICE STRESS TEST:** Failure to take or pass the polygraph/voice stress examination will result in immediate disqualification without recourse.
- E. **LIKENESS/PHOTO RELEASE:** In consideration for permission to participate in the Tournament, I hereby grant to Exelon the unconditional right to use my name, voice, photographic likeness, biographical information, fishing tips and/or instruction in any medium whatsoever, including but not limited to video/audio productions, merchandising, promotions, articles and/or press releases, in connection with this tournament. I understand that I will not be entitled to receive any royalties or other compensation in connection with such use.
