



LRQA Independent Assurance Statement

Relating to Exelon Business Services Company, LLC’s 2024 Utility Residual CO₂ Emissions Rates

This Assurance Statement has been prepared for Exelon Business Services Company, LLC in accordance with our contract.

Terms of Engagement

LRQA was commissioned by Exelon Business Services Company, LLC (Exelon) to provide independent assurance of its 2024 Utility Residual CO₂ Emissions Rates (“the Report”) against the assurance criteria below to a reasonable level of assurance and materiality of 5% using LRQA’s verification procedure. LRQA’s verification procedure is based on current best practice and is in accordance with ISAE 3000 and ISAE 3410.

Our assurance engagement covered Exelon’s preparation of the Report, and specifically the following requirements:

- Verifying conformance with:
 - Edison Electric Institute Instructions and Definitions: Electric Company Carbon Emissions and Electricity Mix Reporting Template for Customers
- Reviewing whether the Report has taken account of:
 - World Resources Institute / World Business Council for Sustainable Development Greenhouse Gas Protocol Scope 2 Guidance: An amendment to the GHG Protocol Corporate Standard¹; and
 - Industry Best Practices.

LRQA’s responsibility is only to Exelon. LRQA disclaims any liability or responsibility to others as explained in the end footnote. Exelon’s responsibility is for collecting, aggregating, analysing and presenting all the data and information within the Report and for maintaining effective internal controls over the systems from which the Report is derived. Ultimately, the Report has been approved by, and remains the responsibility of, Exelon.

LRQA’s Opinion

Based on LRQA’s approach, we believe that Exelon has, in all material respects:

- Met the requirements of criteria listed above; and
- Disclosed accurate and reliable performance data and information as summarized in Table 1 below.

The opinion expressed is formed on the basis of a reasonable level of assurance and at the materiality of 5%.

- Recalculating each utility specific factor based on Exelon's internal procedures and Edison Electric Institute Instructions and Definitions: Electric Company Carbon Emissions and Electricity Mix Reporting Template for Customers;
- Reviewing the emission factors and other data used in the calculations back to the source level; and
- Interviewing relevant staff of the organization responsible for managing utility specific emission factor calculations.
